#### SECTION 4. FIRST AID MEASURES

##### Description of first aid measures

###### **Eye Contact**

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Immediate medical attention is required.

###### **Skin Contact**

Wash off immediately with plenty of water for at least 15 minutes. Remove and wash contaminated clothing before re-use. Immediate medical attention is required.

###### **Ingestion**

Do not induce vomiting. Clean mouth with water. Never give anything by mouth to an unconscious person. Call a physician or Poison Control Center immediately.

###### **Inhalation**

Move to fresh air. If breathing is difficult, give oxygen. Do not use mouth-to-mouth resuscitation if victim ingested or inhaled the substance; induce artificial respiration with a respiratory medical device. Immediate medical attention is required.

CO<sub>2</sub>, dry chemical, dry sand, alcohol-resistant foam. Cool closed containers exposed to fire with water spray.

##### Special hazards arising from the substance or mixture

Flammable. Containers may explode when heated. Vapors may form explosive mixtures with air. Vapors may travel to source of ignition and flash back. The product causes burns of eyes, skin and mucous membranes.
