Fluorides may cause salivation, nausea, vomiting, diarrhea and abdominal pain, followed by weakness, tremors, shallow respiration, convulsions and coma. May cause brain and kidney damage. Chronic fluoride poisoning can cause severe bone changes, loss of weight, anorexia, anemia and dental defects. Organic phosphorus compounds exhibit a wide range of toxicity. Most are skin and eye irritants with the more volatile also being respiratory irritants. Those exhibiting substantial water reactivity will have stronger irritating properties and may be corrosive enough to cause severe burns. Some organic phosphorus compounds are cholinesterase inhibitors. Symptoms associated with these include muscle twitching, convulsions, flaccid paralysis, coma, respiratory failure. They can be highly paralytic.

Inorganic phosphorus compounds may cause irritation and hemorrhages in the stomach as well as liver and kidney damage. Bone structure may be attacked, especially the jaw and teeth.
