Symptoms include sluggishness, sleepiness, muscle weakness, loss of facial muscle control, edema, emotional disturbances, spastic gait and falling. Chronic manganese poisoning may develop after as little as three months of heavy exposure but usually cases develop after one to three years of exposure, Small doses of nitrates may cause weakness, general depression, headache and mental impairment. Larger doses may cause dizziness, abdominal cramps, vomiting, bloody diarrhea, convulsions and collapse.

Additional toxicological information:

To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
