Dichloroanilines are destructive to tissues of the respiratory tract, skin and eyes. Exposure may cause pulmonary disease, coughing, wheezing, laryngitis, shortness of breath, vomiting, nausea and headache. Exposure has also resulted in nerve injury, convulsions, seizures, cyanosis, and gastrointestinal injury.

Additional toxicological information: To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
