2.1. Classification of the substance or mixture

Chemical identity: 2,5-BIS(TRIFLUOROMETHYL)BENZENEBORONIC ACID

Section 4: First aid measures

4.1. Description of first aid measures

Skin contact: Remove all contaminated clothes and footwear immediately unless stuck to skin.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: In combustion emits toxic fumes. Carbon oxides. Hydrogen fluoride (HF). Borane/boron oxides.
