Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: In combustion emits toxic fumes. Carbon oxides. Nitrogen oxides (NOx). Hydrogen bromide (HBr). Hydrogen chloride (HCl).
