## Section 5: Fire-fighting measures

### 7.1. Precautions for safe handling

**Handling requirements:** Avoid the formation or spread of dust in the air. Ensure there is sufficient ventilation of the area. Only use in fume hood. It is recommended to reconstitute the lyophilized PMSG in sterile 18M $\Omega$ -cm H<sub>2</sub>O at a concentration of 1000 IU/ml, which can then be further diluted to other aqueous solutions.

### 7.2. Conditions for safe storage, including any incompatibilities

**Storage conditions:** Store in a cool, well ventilated area. Keep container tightly closed. This item is stable at room temperature for up to 3 weeks only. When reconstituted, it should be stored at 4°C for 2-7days, and for future use at -20°C. PREVENT FREEZE-THAW CYCLES.

**Suitable packaging:** Must only be kept in original packaging.
