### Section 3. Composition/Information on Ingredients

There are no additional ingredients present which, within the current knowledge of the supplier and in the concentrations applicable, are classified as hazardous to health or the environment and hence require reporting in this section.

### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

- General Advice:** Move out of dangerous area. Call a POISON CENTER or doctor/physician immediately. Show this safety data sheet to the doctor in attendance. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.
- Eye Contact:** Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Rinse for a minimum of 15 minutes. Check for and remove any contact lenses after initial rinse period and continue rinsing for an additional 15 minutes. Keep eyes wide open during rinsing process. #### Most Important Symptoms/Effects, Acute and Delayed Potential Acute Health Effects

- Eye Contact:** Causes serious eye damage. Symptoms may include watering, redness, pain, swelling of the eyelids, inability to keep eye open, blurred vision and temporary/permanent loss of vision.
- Inhalation:** Product is extremely corrosive to mucous membranes and tissues of the upper respiratory tract. Symptoms may include a burning sensation, coughing, coughing up blood (hemoptysis), wheezing, laryngitis, shortness of breath/difficulty in breathing (dyspnea), blueness (cyanosis) of lips and skin, nausea, headaches, disorientation, general weakness and loss of consciousness.

### Section 4. First Aid Measures

- Skin Contact:** Skin contact with this product may be expected to cause (severe) chemical burns. Symptoms may include reddening of skin, a burning or itching sensation, pain, blistering and tissue necrosis.
- Ingestion:** Ingestion may be expected to result in burns of the mouth and throat and potential perforation of the esophagus and stomach. Symptoms may include pain when swallowing (odynophagia), difficulty swallowing (dysphagia), fever, nausea, recurrent vomiting (emesis) and vomiting of blood (hematemesis). ### Section 5. Fire Fighting Measures

- General Hazards:** Flammable liquid and vapor. If product is involved in a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. Product releases hydrogen chloride when exposed to water/moist air.
- Suitable Extinguishing Media:** THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. Vermiculite, sand, dry chemical or carbon dioxide (CO<sub>2</sub>) may also be used. Water spray may be used to cool sealed containers.
- Unsuitable Extinguishing Media:** Do not use water (fog, spray or jet). Product reacts with water to release a toxic and corrosive gas (hydrogen chloride).
- Unusual Fire and Explosion Hazards:** Vapor/air mixtures are explosive above flash point. Product runoff to sewer may create a fire or explosion hazard. Vapors/gases released under fire conditions are heavier than air and may spread long distances along the ground. Vapors may accumulate in low or confined areas or travel a considerable distance to an ignition source and flashback.

### Section 5. Fire Fighting Measures

**Product of Combustion:**

Products of complete combustion are carbon dioxide (CO<sub>2</sub>), hydrogen chloride and germanium oxide.

**Protection of Firefighters:**

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Avoid contact with skin or eyes. Avoid breathing dusts, aerosols, vapors and gases.

Eliminate all local and distant ignition sources. Move containers from fire area if process can be accomplished without risk to firefighters. To reduce the possibility of explosion, use a water spray or fog to reduce direct vapors and to cool unopened containers. Do not cut, grind, drill or weld on or near product containers (even empty) of this product because an explosion may result.

Fire-fighters should wear appropriate protection equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in a positive pressure mode.

### Section 6. Accidental Release Measures

**Personal Precautions, Protective Equipment and Emergency Procedures****For Non-Emergency Personnel:**

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Beware of vapors accumulating to form explosive concentrations. Vapors can accumulate in low areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid inhalation of sprays, vapors, gases, aerosols or mists. Provide adequate ventilation. Wear respiratory protection. Put on appropriate personal protective equipment.

**For Emergency Responders:**

If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For Non-Emergency Personnel".

**Environmental Precautions:**

Do not allow dispersal of spilled material and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

### Section 6. Accidental Release Measures

#### Methods for Containment

**General:**

Eliminate all local and distant ignition sources. Move containers from spill area if safe to do so. Avoid allowing the spilled material to get wet or using water to clean up spillages or residues. Use spark-proof tools and explosion-proof equipment.

**Small Spill:**

Contain and collect spillage with non-combustible, dry absorbent material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor.

**Large Spill:**

Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, dry absorbent material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product.

Note: see Section 1 for emergency contact information and Section 13 for waste disposal.

### Section 7. Handling and Storage

**Precautions:**

Product is moisture sensitive; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep away from all sources of ignition – NO SMOKING. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Avoid the formation and inhalation of sprays, mists, vapors and gases. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

**Protective Measures:**

Protect against electrostatic charges. Use explosion-proof electrical/ventilating/lighting/handling equipment. Use only non-sparking tools and equipment. Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

### Section 7. Handling and Storage

#### General Occupational Hygiene:

Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. See also Section 8 for additional information on hygiene measures.

#### Safe Storage Conditions:

Product is moisture sensitive; store under an inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep away from all sources of ignition – NO SMOKING. Store in original container protected from direct sunlight in a dry and well-ventilated area, away from incompatible materials and food and drink. Keep container tightly closed and sealed until ready for use. Store locked up.

### Section 8. Exposure Controls/Personal Protection

#### Introductory Remarks:

These recommendations provide general guidance for handling this product. Because work environments and material handling practices vary, safety procedures should be developed for each intended application. While developing safe handling procedures, do not overlook the need to clean equipment and conduct regular repairs. Waste from these procedures should be handled in accordance with Section 13.

#### Occupational Exposure Limits:

### Section 8. Exposure Controls/Personal Protection

#### Hygiene Measures (cont.):

Do not inhale aerosols, gases, vapors, sprays or mists. Avoid contact with eyes and skin. Ensure that eyewash stations and safety showers are close to the workstation location.

#### Eye/Face Protection:

Safety eyewear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists, gases or aerosols. If contact is possible, the following protection should be worn, unless the assessment indicates a higher degree of protection: chemical splash goggles, faceshield (8-inch minimum).
