### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

- General Advice:** Move out of dangerous area. Consult a physician. Show this safety data sheet to the doctor in attendance.
- Eye Contact:** Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue rinsing. Get immediate medical attention. Seek medical attention if eye irritation develops and persists.

### Section 5. Fire Fighting Measures

#### Large Spill:

#### **Introductory Remarks:**

These recommendations provide general guidance for handling this product.
