#### 4. FIRST AID MEASURES

##### **General advice**

#### 5. FIRE-FIGHTING MEASURES

##### **Suitable extinguishing media**

For small (incipient) fires, use media such as "alcohol" foam, dry chemical, or carbon dioxide. For large fires, apply water from as far as possible. Use very large quantities (flooding) of water applied as a mist or spray; solid streams of water may be ineffective. Cool all affected containers with flooding quantities of water.

##### **Special protective equipment for fire-fighters**

Wear self contained breathing apparatus for fire fighting if necessary.

#### 6. ACCIDENTAL RELEASE MEASURES

##### **Personal precautions**

Use personal protective equipment. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Beware of vapours accumulating to form explosive concentrations. Vapours can accumulate in low areas.

##### **Environmental precautions**

Prevent further leakage or spillage if safe to do so. Do not let product enter drains.

##### **Methods and materials for containment and cleaning up**

Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and place in container for disposal according to local regulations (see section 13).

#### 7. HANDLING AND STORAGE

##### **Precautions for safe handling**

Avoid contact with skin and eyes. Avoid inhalation of vapour or mist.

Keep away from sources of ignition - No smoking. Take measures to prevent the build up of electrostatic charge.

##### **Conditions for safe storage**

Keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage. Store in cool place.

Moisture sensitive. Handle and store under inert gas.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

### Personal protective equipment

#### Respiratory protection

Where risk assessment shows air-purifying respirators are appropriate use a full-face respirator with multi-purpose combination (US) or type ABEK (EN 14387) respirator cartridges as a backup to engineering controls. Use respirators and components tested and approved under appropriate government standards such as NIOSH (US) or CEN (EU).

#### Hand protection

Handle with gloves. Gloves must be inspected prior to use. Use proper glove removal technique (without touching glove's outer surface) to avoid skin contact with this product.
