## SECTION 4: First aid measures

### 4.1. Description of first aid measures

- First-aid measures general : In case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). Move the affected personnel away from the contaminated area.

- Fire hazard : Thermal decomposition generates: Carbon oxides. Hydrogen bromide. Hydrogen fluoride.

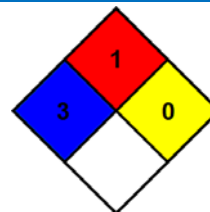
