## SECTION 4: First aid measures

### 4.1. Description of first aid measures

- First-aid measures general : In case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). Move the affected personnel away from the contaminated area.

### 4.2. Most important symptoms and effects, both acute and delayed

- Symptoms/injuries after inhalation : Material is destructive to tissue of the mucuous membranes and upper respiratory tract. Cough, shortness of breath, headache, nausea.

## SECTION 5: Firefighting measures

### 5.1. Extinguishing media

- Suitable extinguishing media : Alcohol resistant foam. Carbon dioxide. Dry powder. Water spray. Use extinguishing media appropriate for surrounding fire.

### 5.2. Special hazards arising from the substance or mixture

- Fire hazard : Thermal decomposition generates: Carbon oxides. Hydrogen chloride. Hydrogen fluoride.
- Explosion hazard : Risk of explosion if heated under confinement. Use water spray or fog for cooling exposed containers.
- Reactivity : Reacts with water, generates gases or heat. Reacts on exposure to water with some metals to release highly explosive/flammable hydrogen gas.

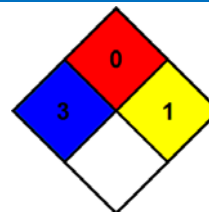
