# 6. ACCIDENTAL RELEASE MEASURES

Prevent dust cloud. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away.
