#### 4. FIRST-AID MEASURES

Skin contact:

Inhalation:

Call a poison center or doctor if you feel unwell. Effects of exposure (inhalation) to substance may be delayed. Inhalation of vapors or contact with substance will result in contamination and potential harmful effects. Move victim to fresh air. Give artificial respiration if victim is not breathing. symptomatically and supportively. Effects of exposure to substance may be delayed. Ensure that medical

personnel are aware of the material(s) involved and take precautions to protect themselves. Ingestion:

Harmful if swallowed. Effects of exposure (ingestion) to substance may be delayed. If swallowed, seek medical advice immediately and show the container or label. Do not use mouth-to-mouth method if victim ingested the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

# 5. FIRE-FIGHTING MEASURES

Suitable extinguishing media:

**Hazardous combustion products:** These products include: Carbon oxides Nitrogen oxides Other specific hazards: Closed containers may explode from heat of a fire.

#### Special precautions for fire-fighters:

# 6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Do not touch

damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn unnecessary personnel to move away. Stop leak if you can do it without risk. Ensure adequate ventilation.

Isolate the hazard area and deny entry to unnecessary and unprotected personnel. Personal protective equipment:

Splash goggles. Wear protective clothing (chemical resistant suit and chemical resistant boots). Dust respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves

(nitrile).

**Emergency procedures:** Prevent dust cloud. Do not clean-up or dispose except under supervision of a specialist. In case of a spill

and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

#### 6. ACCIDENTAL RELEASE MEASURES

#### Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. **Environmental precautions:** 

Keep away from living quarters. Do not let product enter drains. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.

#### 7. HANDLING AND STORAGE
