4. FIRST-AID MEASURES**Inhalation:**

Call emergency medical service. Move victim to fresh air. Give artificial respiration if victim is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

Skin contact:

Call a poison center or doctor if you feel unwell. Remove and wash contaminated clothing before re-use. Remove and isolate contaminated clothing and shoes. In case of contact with substance, immediately flush skin with running water for at least 20 minutes. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

Eye contact:

IMMEDIATELY flush eyes with running water for at least 15 minutes, keeping eyelids open. Contact with material may irritate or burn eyes. Call emergency medical service. Move victim to fresh air. Check for and remove any contact lenses. Keep victim warm and quiet. Treat symptomatically and supportively. Effects of exposure to substance may be delayed. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

Ingestion:

Harmful if swallowed. Do not induce vomiting without medical advice. Call a physician or Poison Control Center immediately. Do not use mouth-to-mouth method if victim ingested the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves.

5. FIRE-FIGHTING MEASURES

Special precautions for fire-fighters:

Use water spray or fog; do not use straight streams. Dike fire-control water for later disposal; do not scatter the material. CAUTION: All these products have a very low flash point: Use of water spray when fighting fire may be inefficient. Do not use straight streams. Runoff to sewer may create fire or explosion hazard. May re-ignite after fire is extinguished. Do not get water inside containers. Cylinders exposed to fire may vent and release gasses through pressure relief devices. Containers may explode when heated. Move containers from fire area if you can do it without risk.

Special protective equipment for fire-fighters:

Wear positive pressure self-contained breathing apparatus (SCBA). Structural fire fighters' protective clothing provides limited protection in fire situations ONLY; it may not be effective in spill situations. Wear chemical protective clothing which is specifically recommended by the manufacturer. It may provide little or no thermal protection.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions:

Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Use spark-proof tools and explosion-proof equipment. Remove all sources of ignition. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn unnecessary personnel to move away. Stop leak if you can do it without risk. Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel.

Personal protective equipment:

Wear eye protection (splash goggles) and face protection (full length face shield). Lab coat. Vapor respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile).

Emergency procedures:

Do not use water as spilled material may react with it. Isolate area until gas has dispersed. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in the immediate area). Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Do not direct water at spill source. DO NOT get water inside container. All equipment used when handling the product must be grounded. Absorb with DRY earth, sand or other non-combustible material. Use clean non-sparking tools to collect material and place it into loosely covered plastic containers for later disposal. Do not clean-up or dispose except under supervision of a specialist. Ventilate the area.

Environmental precautions:

Keep away from living quarters. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.

7. HANDLING AND STORAGE

Precautions for safe handling:

Do NOT breath gas, fumes, vapor, or spray. Do not ingest. Avoid contact with skin and eyes. Avoid contact with skin. Keep away from heat and sources of ignition. Use explosion-proof equipment. Use only non-sparking hand tool when handling this product. Ground all equipment containing material. Take measures to prevent build up of electrostatic charge. Never add water to this product. Good general ventilation should be sufficient to control airborne levels. Keep container dry. Handle and open container with care. Wear suitable protective clothing, gloves and eye/face protection. When using do not eat, drink, or smoke. Keep away from sources of ignition.

Conditions for safe storage:

Keep away from sources of ignition. Store and use away from heat, sparks, open flame, or any other ignition source. Store in a cool, dry place. Keep containers tightly closed in a dry, cool, and well-ventilated place. Keep away from incompatibles. Containers which are opened must be carefully resealed and kept upright to prevent leakage.
