4. FIRST-AID MEASURES

Skin contact:

Call a poison center or doctor if you feel unwell. Effects of exposure (inhalation) to substance may be Inhalation:

Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. **Environmental precautions:**

Keep away from living quarters. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.
