Suitable extinguishing media:

Personal precautions:

Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile). Emergency procedures: Prevent dust cloud. Isolate area until gas has dispersed. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

Methods and materials for containment and cleaning up:

Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.
