6. ACCIDENTAL RELEASE MEASURES Personal precautions: Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Use sparkproof tools and explosion-proof equipment. Remove all sources of ignition. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn unnecessary personnel to move away. Stop leak if you can do it without risk. Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel. Wear eye protection (splash goggles) and face protection (full length face shield). Lab coat. Vapor Personal protective equipment: respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile). Isolate area until gas has dispersed. In case of a spill and/or a leak, always shut off any sources of ignition, **Emergency procedures:** ventilate the area, and excercise caution. Methods and materials for containment and cleaning up:

Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.
