Inhalation:	May cause coughing, difficult breathing and nausea. Immediately call a poison center or doctor. Effects of exposure (inhalation) to substance may be delayed. Personal precautions:	Avoid contact with skin, eyes, and clothing. Keep people away from and upwind of spill/leak. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing (Section 8). Warn unnecessary personnel to move away. Stop leak if you can do it without risk. Ensure adequate ventilation. Isolate the hazard area and deny entry to unnecessary and unprotected personnel.
Personal protective equipment:	Wear eye protection (splash goggles) and face protection (full length face shield). Wear protective clothing (chemical resistant suit and chemical resistant boots). Dust respirator. Be sure to use a MSHA/NIOSH approved respirator or equivalent. Wear protective gloves (nitrile).
Emergency procedures:	Prevent dust cloud. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. #### Methods and materials for containment and cleaning up:

Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material. **Environmental precautions:**
