# 4. FIRST-AID MEASURES

Eye contact:

Inhalation: Call a poison center or doctor if you feel unwell. Move victim to fresh air. Give artificial respiration if victim

is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat

symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and

**Emergency procedures:** 

Isolate area until gas has dispersed. In case of a spill and/or a leak, always shut off any sources of ignition, ventilate the area, and excercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away.
