# 4. FIRST-AID MEASURES

Ingestion: Do not induce vomiting with out medical advice. If swallowed, seek medical advice immediately and show

Do not use mouth-to-mouth method if victim ingested the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. # 6. ACCIDENTAL RELEASE MEASURES

## Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Ventilate the area.
