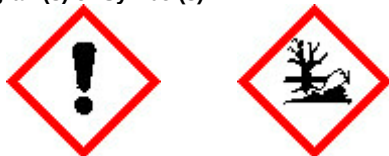

Dike far ahead of spill; use dry sand to contain the flow of material. Ventilate the area.
