4. FIRST-AID MEASURES

Eye contact:

Inhalation: Immediately call a poison center or doctor. Move victim to fresh air. Give artificial respiration if victim is not

breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take

precautions to protect themselves.

Skin contact: Immediately call a poison center or doctor. Remove and wash contaminated clothing before re-use.

Remove and isolate contaminated clothing and shoes. In case of contact with substance, immediately flush skin with running water for at least 20 minutes. Treat symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and take precautions to protect themselves. IMMEDIATELY flush eyes with running water for at least 15 minutes, keeping eyelids open. Eye contact

with vapors or substance may cause severe injury, burns, or death. Call emergency medical service. Move victim to fresh air. Check for and remove any contact lenses. Keep victim warm and quiet. Treat

symptomatically and supportively. Effects of exposure to substance may be delayed. Ensure that medical
