4. FIRST-AID MEASURES

Inhalation: Call a poison center or doctor if you feel unwell. Move victim to fresh air. Give artificial respiration if victim

is not breathing. Administer oxygen if breathing is difficult. Keep victim warm and quiet. Treat

symptomatically and supportively. Ensure that medical personnel are aware of the material(s) involved and

Skin contact: If skin irritation occurs get medical advice/attention. Remove and wash contaminated clothing before reuse. In case of contact with substance, immediately flush skin with running water for at least 20 minutes.

Treat symptomatically and supportively. Effects of exposure to substance may be delayed. Ensure that medical personnel are aware of the material(s)

Ingestion:Do not induce vomiting with out medical advice. If swallowed, seek medical advice immediately and show the container or label. Do not use mouth-to-mouth method if victim ingested the substance; give artificial

respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth. Keep victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware of the

material(s) involved and take precautions to protect themselves.

5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Methods and materials for containment and cleaning up:

Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.

7. HANDLING AND STORAGE

should be sufficient to control airborne levels. Keep container dry. Handle and open container with care. Wear suitable protective clothing, gloves and eye/face protection. When using do not eat, drink, or smoke.

Keep away from sources of ignition.

Conditions for safe storage: Keep only in the original container in a cool well-ventilated place. Keep away from incompatibles.
